This is a binding legal agreement. As a Participant in the programs, activities and events of **Euro Futbol for Champions**, the undersigned acknowledges and agrees to the following terms:

Disclaimer:

Euro Futbol for Champions (the "Organization"), their directors, officers, members, employees, coaches, volunteers, officials, participants, clubs, agents, sponsor, owners/operators of facilities and representatives (the "Organization") **is not responsible for** any injury, damage or loss of any kind suffered by a Participant during, or as a result of, any program, activity or event, caused in any manner whatsoever including, but not limited to, the negligence of the Organization.

Description of Risks:

In consideration of my participation in such programs, activities and events, I hereby acknowledge that I am aware of risks and hazards associated with or related to soccer. The risks and hazards of soccer include, but are not limited to:

- Injuries from executing strenuous and demanding physical techniques in soccer;
- Injuries from dry land training including weights, running and massage;
- Injuries from grass, turf, and other surfaces including bacterial infections and rashes;
- Injuries resulting from falls to the ground due to an uneven or irregular terrain or surfaces;
- Injuries from collisions with walls and soccer equipment;
- Injuries resulting from failure to properly use any piece of equipment or from the mechanical failure of any piece of equipment;
- Spinal cord injuries which may render me permanently paralyzed;
- Injuries from extreme weather conditions which may result in heart stroke, sunstroke or hypothermia;
- Injuries from contact, colliding or being struck by other participants, spectators, equipment or vehicles;
- Injuries resulting from vigorous physical exertion and strenuous cardiovascular workouts;
- Injuries from exerting and stretching various muscle groups; and
- Travel to and from competitive events and associated non-competitive events, which are in integral part of the Organization's activities.

Furthermore, I am aware:

- That injuries sustained in soccer can be severe;
- That I may come into close contact with other participants, including the possibility of accidental and unexpected contact;
- That I may experience anxiety while challenging myself during activities;
- That my risk of injury is reduced if I follow all rules adopted during training; and
- That my risk of injury increases as I become fatigued

Release of Liability

In consideration of the Organization's allowing me to participate, I agree:

- a) To assume all risks arising out of, associated with or related to my participation
- b) To be solely responsible for any injury, loss, or damage that I might sustain while participating; and
- c) To release the Organization from liability for any and all claims, demands, actions or costs which may have been caused by negligence of the Organization.
- d) To permit the Organization to use any photos taken during the camps that my child may appear on providing that the name not appear unless agreed to in writing, for the purpose of any marketing and advertising medium.
